



# INTERNAL RULES

The Campsite is open from March to September.

[RULES >](#)

1. Camping Admission depending on Administration Staff.
2. The area where camp will be showed by the Camping's Administration Staff and all directions have to be observed
3. Camping's guests, on arrival, have to show their documents and the Administration could keep them until the guests departure.
4. Guests have to declare any extras such as electricity, tents, motorcycle, rubber dinghy etc. and say in advance any change of place, any change of arrival or departure data of any members of the group.
5. Guests should show any possible arranged cards. The agreement begins when the card is handed over to the Administration staff. In order to get any offers or discounts, you have to pay cash.
6. The Administration reserves the right to change the camping area already assigned with a different one having the same characteristics, if necessity arises.
7. The assigned camping areas will be kept till 12 a.m. (Maxicaravan till 10 a.m.) of the day following the expected date of arrival. In case of previous departure the deposit will be kept by the administration.
8. Daily fares, display in the reception, will be applied from the arrival data until 12 a.m. of the followin day.
9. The Camping's bill should be paid the day before departure within 4 o'clock in the afternoon, regarding Maxicaravan bill have to be paid within 2 days from arrival.

## VISITS

1. Visits are admitted only with the Administration's authorization, during visiting time (8.00-22.00). One hour visits are free, longer visits will be subjected to the daily fees. Visitors having dogs with them are not allowed.
2. Visitors getting in the camping site, have to show a document and cannot get inside camping by car.
3. Visitors in the camping site without authorization will be reported to the Police.
4. Cars and motorbikes in the Parking Area without the authorization will be removed by policemen.

## SILENCE

1. From 1.00 pm to 2.30 pm and from 11.00 pm to 7.30 am the silence has to be respected.
2. The Camping's guests are requested not to make noise also in daytime. Radio and TV sets are allowed only kept at very low volume.

## CARS AND TRAFFIC

1. Only one car per place is allowed in the cap site , other cars are admitted just to load or unload then they must be parked in the external private parking area.
2. From 1 p.m. to 2.30 p.m. the traffic is authorized only for emergency
3. The speed limit is of 5 km/h even on the main lane.

## VALUES CARE:

1. Each guest will have to look after his own properties. The Administration declines any responsibility for losses or thefts.

## PROHIBITIONS

1. It's strictly forbidden to make open fires. The use of a barbecue is allowed only when it gives no nuisance to neighbours and does not damage the lawn or the ground.
2. It is strictly forbidden to damage green plants and Camping's equipment, to dig hollow ditches around tents, to change in any way the area assigned for camping, to throw on the ground hot, salted or waste liquids of any kind.
3. It's forbidden to drive cars within the Camping from 11 p.m. to 7.30 a.m.
4. It's forbidden to stop and wash your cars, camper, boats etc. in the external area used for the "Camper Service".
5. It is forbidden to play soccer ball, bowls and volleyball out of the relative grounds.
6. The Camping's guests should follow paths when walking in the Camping, avoiding crossing other

guests' camping areas, even if large enough. The use of bicycles by children is allowed just on the road of the camping site, and strictly forbidden on the pitches. The parents are heavily recommended to be sure that these rules will be respected.

7. Water pistols are strictly forbidden in the toilets and generally on the whole camping site.
8. Dogs are not admitted during the high season (08.07-26.08). Big and aggressive dog will never be admitted.

## RESPONSIBILITY

1. Parents must always be with their children when they go to toilets or they use sports equipment and facilities. Parents are responsible for their own children. The Administration Staff declines any responsibility regarding children

## CORRESPONDENCE

1. Personal correspondence has to be picked up only by the owner After 7 days from the correspondence arrival, it was not collected we ought send it back to the sender.

## DISEASES

1. Any infections disease has to be declared to the Administration's staff

## DIFFERENTIATED WASTE DISPOSAL

1. In our camping, customers should separate the different kind of rubbish: paper, glass, plastic and aluminium. On the back of this prospectus you have the instructions how to dispose waste. In front of the Reception's office you find dustbins for recycling. Regarding iron and cardboard waste, please ask to Reception's staff.
2. Chemical WC tanks have to be emptied and rinsed in the special room marked "WC KIMIK" placed in the toilette-building.
3. The owners of Camper can use the "Camper Service" places in the external parking area.



## BOATS

1. Boats owners have to bring with them Regulations regarding boats, please ask the Administration staff your own copy.
2. The Administration will assign buoy and the parking area for the boat-trailer on which should be clearly visible the sticker given by the Administration itself.
3. The owners of rubber dinghy, canoe, surfboard can not leave their crafts on the beach.

## ANIMALS

From 25/03 till 08/07 and from 26/08 till 24/09

1. Camping entry regarding dogs or other animals depends on the Administration's staff. When admitted the owners will have to strictly observe the Regulation act regarding animals (ask the Administration's staff for a copy). During the high season dogs won't be admitted.
2. Entry into the Camping involves full acceptance of the present internal Regulations for dog and boats owners. Depending on the Administration Staff regulations could be increased for a better management of the camping
3. All these regulations may be implemented by other ones, issued by the Administration if considered suitable for a better management of the Camping.
4. Camping's staff is authorized to enforce rules and report any misbehaviour.
